

## **Non-Exclusive Educational Screening License**

### **1. Grant of License**

The Licensor grants the Licensee a **limited, non-exclusive, non-transferable license** to screen the film *The Cat That Lives in Your Dreams* (the “FILM”) **one time** for an educational, non-commercial event on:

This license permits:

- A single, in-person classroom or campus screening for students and invited guests, for educational purposes only.
- No admission fee to be charged for the screening (except, if needed, standard institutional course or student fees unrelated to this specific event).

No transfer of copyright or other ownership interests is made by this Agreement. The Licensor retains all rights, title, and interest in and to the FILM.

### **2. Format and Access to the Film**

The Licensor will supply a **digital screening file** (e.g., streaming link or downloadable file) for the sole purpose of this screening. The Licensee agrees that:

- The FILM file and/or streaming link will only be accessed by the organizer and technical staff as needed to facilitate the event.

- The FILM file and/or link will **not** be posted publicly, shared for open download, or circulated to attendees beyond what is necessary to conduct the screening itself.
- After the screening, any downloadable local copy of the FILM will be deleted from local devices and storage, and any temporary streaming access will be disabled or allowed to expire, as applicable.

### 3. Limitations on Use

The Licensee expressly agrees that:

- The FILM will be used **only** for the permitted purposes described in this Agreement and for no other purpose.
- The FILM will **not** be:
  - duplicated or copied (in whole or in part),
  - sold, loaned, or rented,
  - broadcast on television or radio,
  - uploaded or made available on any public or institutional streaming platform, course management system, or website, or
  - shared with any third party (including other campuses or institutions) outside this Agreement.

Any additional use (e.g., further screenings, online streaming access, inclusion in a course site, or use at other campuses) requires a **separate written license** from the Licenser.

### 4. No Modification; Respectful Context

The Licensee agrees not to alter, edit, or modify the FILM in any way (including image, sound, subtitles, or captions), except as may be required for accessibility (e.g., closed captions, audio description) and only with prior written consent from the Licenser.

The Licensee agrees to:

- Present the FILM in a respectful, non-exploitative educational context.
- Not use the FILM in any context that promotes discrimination, ableism, or prejudicial representations of disabled people.

### 5. Fees

## 6. Representations and Warranties

The Licensor represents that they are the copyright owner of the FILM and have the authority to grant this limited license, subject to existing agreements with participants and collaborators.

The Licensee acknowledges that the Licensor's commitments to participants and collaborators include maintaining control over the circulation of the FILM, and agrees to abide by the access and circulation limits described in this Agreement.

## 7. Term and Entire Agreement

This license is valid **only for the Screening Date specified above**. Any change of date, additional screening, or additional use must be requested in writing and approved in writing by the Licensor.

This Agreement constitutes the entire understanding between the parties concerning the screening described herein and may only be modified by a written document signed by both parties.
